After 60 days, THERE IS NO RECLAIMING UNSOLD ITEMS and they become the property of The Sassy Peacock. If damage or flaws are found during the pricing of your items, we will donate them to local charities. For any damaged items priced \$40.00 or more, you will receive a phone call for you to pick up or suggest donation preference. We donate to SAFE NET, The City Mission and Childrens Hospital of Pittsburgh. No Reclaiming items priced under \$40.00.

We accept upscale ladies’ and men’s clothing and accessories including; formal wear, shoes, purses and jewelry. All items must be on HANGERS, in style (no more than 2 years old), in season, clean, pressed and odor-free. Formal wear needs to be dry-cleaned. We select items based on current styles, condition, brands and inventory levels. We also except small accent furniture pieces such as curios, dressers, chairs and home decor items that are in excellent to good condition.

Pricing is determined by The Sassy Peacock to best sell your items(s) at the most profitable price. Items may be reduced at the discretion of The Sassy Peacock at any time. **Please Note:** At the end of each season, items will be on clearance up to 50% off to make room for the next season’s merchandise. All Holiday items, regardless of consignment start date, will be reduced to 50% off the day after the holiday. The Sassy Peacock reserves the right to decline merchandise at its own discretion.

Your itemized inventory list will have prices listed. A small buyer’s fee, paid by the person who purchases the item will be added to the price. It will not affect your share. You receive 40% of store price for items priced under \$50.00 and 50% for items priced at \$50.00 or more, less any scheduled markdowns. We only offer cash buyouts for costume jewelry. The proceeds of your merchandise must be retrieved within one year from the 60-day expiration date of each consignment date or they will be forfeited. Checks will be mailed for amounts owed over \$50.00 at the end of each month. A \$1.00 processing fee will be deduct-ed from your account for each mailed check.
